RESOLUTION NO. 5-2021

A RESOLUTION OF NECESSITY PURSUANT TO SECTION 5705.03 OF THE REVISED CODE REQUESTING THE OTTAWA COUNTY AUDITOR TO CERTIFY TO THE COUNCIL OF THE VILLAGE OF MARBLEHEAD, OTTAWA COUNTY, OHIO, THE TOTAL CURRENT TAX VALUATION OF THE VILLAGE OF MARBLEHEAD, OHIO AND THE DOLLAR AMOUNT OF REVENUE THAT WOULD BE GENERATED BY AN ADDITIONAL TWO (2.0) MILL CONTINUING TAX LEVY FOR THE PURPOSE OF GENERAL CONSTRUCTION, RECONSTRUCTION, RESURFACING, AND REPAIR OF STREETS, ROADS, AND BRIDGES IN THE MUNICIPAL CORPORATION AND FOR CONSTRUCTING, REHABILITATING, REPAIRING, OR MAINTAINING SIDEWALKS, WALKWAYS, TRAILS, BICYCLE PATHWAYS OR SIMILAR IMPROVEMENTS, OR ACQUIRING OWNERSHIP INTERESTS IN LAND NECESSARY FOR THE FOREGOING IMPROVEMENTS AND DECLARING AN EMERGENCY

WHEREAS, Section 5705.03 of the Ohio Revised Code requires the taxing authority of each subdivision to certify to the county auditor a resolution or ordinance requesting that the county auditor certify to the taxing authority the total current tax valuation of the subdivision, and the number of mills required to generate a specified amount of revenue, or the dollar amount of revenue that would be generated by a specified number of mills prior to submitting any tax levy to the voters of the subdivision; and

WHEREAS, Council has determined that it is necessary to submit to the voters at the election to be held on November 2, 2021, the question of an additional two (2.0) mill tax levy for the purpose of general construction, reconstruction, resurfacing, and repair of streets, roads, and bridges in the municipal corporation and for constructing, rehabilitating, repairing, or maintaining sidewalks, walkways, trails, bicycle pathways or similar improvements, or acquiring ownership interests in land necessary for the foregoing improvements as authorized by Section 5705.19 (PP) of the Ohio Revised Code; and

WHEREAS, Council has also determined that the submission of the question of an additional two (2.0) mill tax levy for the purpose of general construction, reconstruction, resurfacing, and repair of streets, roads, and bridges in the municipal corporation and for constructing, rehabilitating, repairing, or maintaining sidewalks, walkways, trails, bicycle pathways or similar improvements, or acquiring ownership interests in land necessary for the foregoing improvements as authorized by Section 5705.19 (PP) of the Ohio Revised Code, is necessary for the proper financial operation of the Village, which is directly related to the health, safety and welfare of the Village, and in order to submit the aforesaid tax levy to the Ottawa County Board of Elections on or before August 4, 2021, the deadline for having said levy placed upon the ballot for the election to be held on November 2, 2021; Village Council must waive the three (3) readings and pass by emergency.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF MARBLEHEAD, OTTAWA COUNTY, STATE OF OHIO, two-thirds (2/3) of all members elected thereto concurring:

Section 1: That pursuant to section 5705.03 of the Ohio Revised Code, the Council of the Village of Marblehead, Ohio, requests that the Ottawa County Auditor certify to this Council the total current tax valuation of the Village of Marblehead, Ohio, and the dollar amount of revenue that would be generated by an additional two (2.0) mill tax levy for the purpose of general construction, reconstruction, resurfacing, and repair of streets, roads, and bridges in the municipal corporation and for constructing, rehabilitating, repairing, or maintaining sidewalks, walkways, trails, bicycle pathways or similar improvements, or acquiring ownership interests in land necessary for the foregoing improvements as authorized by Section 5705.19 (PP) of the Ohio Revised Code. Such tax levy shall be placed upon the tax list and duplicate for the current tax year beginning in 2021, first due in calendar year 2022, if a majority of the electors voting thereon in favor thereof and continue for a continuing period of time.

<u>Section 2:</u> That the Fiscal Officer of the Village be, and she hereby is, directed to immediately certify a copy of this Resolution to the Auditor of Ottawa County, Ohio, in order to obtain the information necessary to submit the above-mentioned tax levy to the electors of said Village at the election to be held November 2, 2021.

Section 3. That it is found and determined that all formal actions of the Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public in full compliance with applicable legal requirements, including §121.22 of the Revised Code.

Section 4: This Resolution is hereby declared an emergency measure for the immediate preservation of the public peace, health, and safety of the Village of Marblehead, and for the further reason that in order to submit the aforesaid tax levy to the Ottawa County Board of Elections on or before August 4, 2021, the deadline for having said levy placed upon the ballot for the election to be held on November 2, 2021, Village Council must pass by emergency, and therefore this resolution shall go into immediate effect.
